2	U P	District	<ul style="list-style-type: none"> ➤ 3 persons, per subject for each center, three mandals to be clubbed to form a centre at this level.
3	Organization of Centers at UP level		<ul style="list-style-type: none"> ➤ Centers may be organized separately for languages and Non- Languages with CDs and observes separately.
4	Course Directors		<ul style="list-style-type: none"> ➤ DIET Principal / AMO acts as the Course Coordinator at District Level. ➤ The H.M of the School (Venue) where the training is organized shall acts as the Course Director.
